2018 Southern Indiana Bacon & Blues Festival Terms and Conditions Form

1. **Setup/Breakdown:** All Exhibitors must be set up and ready to sell by 11:00 am the day of the festival. Exhibitors may begin setting up on Friday, October 5th from 4:00 pm – 8:00 pm or Saturday, October 6th from 8 am – 11 am. Vehicles must be off the grounds by 11:00 am each day of the festival. Booths shall be open Saturday from 12:00 pm – 8:00 pm. and from 12:00 pm – 6:00 pm on Sunday. Breakdown can start no sooner than 5:00 pm on Sunday. Sellers are responsible for their selling spaces. Before leaving, be sure your areas is clean and trash-free.
2. **Staffing:** Exhibitors tables/booths must be manned at all times and intact during the festival. Each booth will be issued 2 car passes so that you or your workers will not be charged entry to the grounds. Best Vineyard and Winery and the Elizabeth Lions Club are not responsible for merchandise or display materials.
3. **Exhibitor Items:** All food vendors must have filed a **TEMPORARY EVENT FOOD SERVICE APPLICATION** with the Harrison County Health Department and submit a copy to Best Vineyards. Any vendor selling food or products that can be absorbed through the skin must submit a copy of liability insurance to Best Vineyards. In keeping with the Bacon Festival theme, all Exhibitors are required to sell something bacon or pig related in their booths.
4. **Exhibitor Responsibility:** Exhibitor will be responsible for any loss or damage to his or her property by theft, fire or casualty. Best Vineyards and Winery and the Elizabeth Lions Club expressly disclaims any responsibility for same. Exhibitors shall be responsible for any damage which may be incurred to the facilities as a result of or in connection with its operation. Each Exhibitor is responsible for the conduct of his/her employees and/or representative and activities must not detract from the image or welfare of the festival.
5. **Exhibitor Spaces:** Exhibitor spaces will be assigned. Placement, flow and competition will be taken into consideration to provide the best experience for all attendees. Spaces are reserved on a first-come, first-served basis. Since this is an outdoor event, it is advised to bring along shims or blocks of wood to level out the tables. The ground is uneven and sloped in some areas. All tents and canopies must be secured to the ground using weights/sand bags in case of windy weather. Exhibitor will furnish his or her own table and chairs.
6. **Acceptance:** Best Vineyards and Winery and the Elizabeth Lions Club reserves the right to decline any application for space if it deems such action to be in the best interest of the festival.
7. **Payment:** The full payment is a non-refundable fee for the selected space and is due with the submission of the agreement. This fee will be used to cover advertising and other incidental costs associated with the production of the event. If your application is received, and all spaces and categories are full, your application and payment will be returned to you.
8. **Electricity:** Electricity will be available only to food vendors as electricity is not available at all areas. Electrical service requires an addition fee. Outlets are NOT guaranteed and extension cords are not included in the fee and must be provided by the Exhibitor.
9. **Cancellation of space:** Application fees that have been approved are non-refundable. The festival will take place weather permitting. Best Vineyards and Winery and the Elizabeth Lions Club are not liable if weather or other conditions prevent the Exhibitor from attending and fulfilling the contractual obligation as an Exhibitor. No refunds will be made for accident, health or other causes for non-participation. Full refunds will only be issued to vendors if the entire 2 day event is cancelled.
10. **Indemnification:** Exhibitor agrees to indemnify and hold harmless Best Vineyards and Winery and the Elizabeth Lions Club from and against any loss, expense, claims, damages, causes of action, injuries, suits or damages, suits to person or property, including attorney's fees, arising out of or related to the operation of the Exhibitors at the Southern Indiana Bacon & Blues Festival.
